So, we want to know who you are, and to provide on-camera roles for you in some of the content that streams on the platform. Here's what that means, including the terms and conditions to be an active participant with the DFE website or platform in general and also with the "Eternal Impact" promotion.

First, if you continue to browse and use the Divine Family Entertainment website or platform, you are agreeing to comply with and be bound by the terms and conditions of use, which together with our privacy policy govern Divine Family Entertainment's relationship with you in relation to this website. Your interview will run or be released at DFE's sole discretion. Here are a few reasons DFE might not run or release your interview (but not limited to these):

- e. the sound or video quality is poor
- f. the interview failed to record
- g. the chosen topic does not align with DFE values
- h. interview content could open the door to litigation against DFE
- i. interview content contains copyrighted material
- j. technical difficulties.

DFE will work to make your interview happen within two weeks after your contribution. But please allow 3 to 6 months in case of unforeseen circumstances. If after 6 months your interview has not been scheduled, contact DFE to reschedule or redeem DFE merchandise in place of the interview.

If advertisers pay to place their ads on your interview, you will receive a portion of the ad revenue.



So tell everyone you know to contact DFE, if they would like to attach a short commercial to your interview. If they need help making the commercial, DFE can work with them to do that. Once they pay to advertise on your interview, you'll receive funds from DFE. DFE will send you a monthly report of the funds your interview has generated (if funds are received) and how much you will receive. DFE will have sole discretion regarding the amount of funds you receive from the advertising revenue.

Your cameo appearance means that your face will be shown clearly in a scene of a DFE movie, series or show or content created through our partners. At DFE's sole discretion, you may be given a scripted line or lines to say in the production. For news or talk shows, we may ask you to record with video your opinion on a certain topic and we may include your response in a segment. While your cameo appearance may be recorded, it is possible that it could be cut during editing for a variety of reasons including, but not limited to:

- a. the sound or video quality is poor
- b. the cameo appearance failed to record
- c. the scene needed to be cut
- d. there was not enough time to include it
- e. technical difficulties

DFE will make every reasonable effort to record, release and run your appearance in a designated production discussed with you ahead of time, but cannot guarantee that it will stream on DFE, DFE's social media, or anywhere else. Your cameo appearance will be recorded, run or be released at DFE's sole discretion. DFE may request you to make a video of yourself on your cell phone or other camera to send to DFE to include in a production. Or DFE may invite you to a set where on-location recording will take place. If DFE is unable to include you in an agreed-upon production, we will make every reasonable effort to include you in a different production, selected at DFE's sole discretion.

DFE will work to make your cameo appearance happen within two years after your contribution. But please allow 3 to 5 years in case of unforeseen circumstances. If after 5 years your cameo appearance has not been scheduled, contact DFE to reschedule or redeem DFE merchandise in place of the appearance.
